#### **III. ELIGIBILITY FOR NOMINATION TO EXECUTIVE COMMITTEE**

Any member of IANCAS, except the associate members, shall be eligible to contest the election for the **Executive Committee, provided :-**

- (a) She/he has been a continuous member of IANCAS from on or before 01/12/2021 (minimum two years from the date of election announcement).
- (b) She/he does not have arrears of any dues <u>as on 20/11/2023</u> as per the Association's Register of membership.
- (c) President, Vice-Presidents, General Secretary, Joint Secretary, Treasurer, Joint Treasurer and Editor of the Out-going Committee are <u>not eligible to contest for the same post</u>.

#### IV. ELIGIBILITY FOR VOTING

All members who do not have arrears of membership as on 20/11/2023 are eligible to vote in the election.

#### V. PROCEDURE FOR NOMINATION

All nominations have to be made in the prescribed Proforma as enclosed herewith. Photocopies of the nomination form may also be used, if necessary. Each nomination shall be proposed and seconded by eligible members. The prospective nominee shall confirm his willingness by signing on the nomination form.
